### Minnehaha County Passes CO2 Pipeline Ordinance

The Minnehaha County Commission recently passed a setback pertaining to carbon dioxide pipelines. After public testimony and debate, the Commission agreed to the following table for setbacks.

TRANSMISSION PIPELINE MINIMUM SEPARATION CRITERIA	
Dwellings, Churches, and Businesses	330 ft
Public Parks and Schools	1,000 ft
Municipal Boundaries By the Following Municipal Classification as of the most recent Census Data	
First Class (Population of 5,000 and over)	5,280 ft (1 mile)
Second Class (Population between 500 and 5,000)	3,960 ft (3/4 mile)
Third Class (Population of less than 500)	2,640 (1/2 mile)

The separation distance set forth in the table is to be measured from the center line of the proposed pipeline to the closest parcel boundary of a use or municipal boundary set forth in the table except for dwellings, churches, and businesses which are measured to nearest point of the physical structure.

After the amendment was adopted, the Commission voted 4-1 in favor of the ordinance.

### FCC Releases Second Version of National Broadband Map

The FCC has released its latest iteration of the National Broadband Map. This new version incorporates changes in response to concerns and challenges raised following the release of the initial draft map in November 2022. According to FCC Chairwoman Rosenworcel, "Over 75% of those challenges have already been resolved and the majority have led to updates in the data on the map showing where broadband is available. At the same time, the new map also reflects a net increase of more than one million new serviceable locations, as compared to the November 2022 pre-production draft."

The FCC will release a major update to the map twice a year, which overlays availability data from providers onto the tens of millions of serviceable locations. An accurate map is crucial for targeting funding and other efforts to bring broadband to unserved and underserved communities.

#### Governor Noem Appoints Chris Schilken as Commissioner of GOED

Governor Krisi Noem announced that Chris Schilken will be the new Commissioner of the Governor's Office of Economic Development (GOED).

Prior to being appointed Commissioner, Schilken served a dual role as GOED's Deputy Commissioner and Director of Business Development. With a background in economic development, he has overseen over 100 projects, valued at billions of dollars in capital investment for the state of South Dakota. Schilken's actions have also aided in the addition of 7,000 jobs and 150 projects in the past five years.

#### **Upcoming Cutoff Date for Dicamba Use in South Dakota**

South Dakota pesticide applicators will be facing an upcoming dicamba application cutoff date. In South Dakota, over-the-top dicamba applications cannot be made <u>after June 20</u>.

Affected products include Bayer CropScience's Xtendimax plus VaporGrip Technology, BASF's Engenia Herbicide, and Syngenta Crop Protection's Tavium plus VaporGrip Technology.

## Antibiotic Marketing Changes Coming June 11th

Beginning June 11, 2023, over the counter (OTC) medically important antibiotics for livestock will require a prescription from your veterinarian. To purchase the OTC antibiotics, livestock producers will now be required to have a veterinarian-client-patient relationship (VCPR).

Examples of some commonly used medically important antibiotics for livestock with label changes to veterinary prescription only status by June 2023:

- Oxytetracyclines
  - Injectables: Liquamycin LA-200, Noromycin 300 LA, Bio-Mycin 200, Agrimycin 200, etc.
  - Boluses: Terramycin Scours Tablets, OXY 500 Calf Boluses
- Penicillins (Penicillin G procaine, penicillin G benzathine)
  - o Injectables: Penicillin Injectable, Dura-Pen, Pro-Pen-G, Combi-Pen 48, etc.
  - o Intramammary tubes: Masti-Clear, Go-dry, Albadry Plus
- Sulfa-based antibiotics (sulfadimethoxine, sulfamethazine)
  - o Injectables: Di-Methox 40%, SulfMed 40%
  - Boluses: Albon, Sustain III Cattle & Calf Boluses, Supra Sulfa III Cattle & Calf Boluses
- Tylosin
  - Injectables: Tylan 50, Tylan 200
- Cephapirin, cephapirin benzathine
  - Intramammary tubes: ToDAY and ToMORROW

To prepare for the change, you can start to:

- a. Talk to a veterinarian.
- b. Build a Veterinarian-Client-Patient Relationship (VCPR).
- c. Schedule routine visits.
- d. Set treatment protocols and on-farm training for employees.
