- 3. The student must be pursuing a two or four year degree in a course of study in higher education which is related to agriculture. This could be any subject related to science, production, economics, etc., at a four year institution; or may be a course of study such as diesel mechanics, farm business or production, etc., at any two year institution.

WALWORTH COUNTY FARM BUREAU SCHOLARSHIP

The Walworth County Farm Bureau is pleased to offer a \$1,000 college or vocational school scholarship, with the first recipient to be named in May 201_. The recipient or the recipient's parents must be a member of the Walworth County Farm Bureau. The recipient must be pursuing a degree in agriculture or a major related to agriculture. One scholarship per year will be awarded providing that qualified applications are received.

The funds for this scholarship will be deposited with the Oahe Foundation, a subsidiary of BankWest, and administered by this foundation. Funds will be dispersed to the recipients solely at the direction of the Walworth County Farm Bureau board of directors.

CRITERIA AND GUIDELINES

- Applicants or parents/guardians must have been a member of Walworth County Farm Bureau for a minimum of one year prior to application.
- The applicant must be pursuing a two or four year degree in a field of agriculture, or a field of higher education related to agriculture.
- The applicant must be accepted by an accredited school of higher learning and have a plan of study of a minimum of one year remaining.
- Applicant must be a minimum of 17 years old and a high school Senior, or the
 equivalent thereof; OR is a high school graduate, or the equivalent thereof, and will
 be enrolled as a college freshman, sophomore, junior or senior in the upcoming
 school year.
- Applicants must include their most recent grade transcripts. High school seniors must include a copy of their ACT score.
- The applicant must have maintained a minimum grade point average of 2.5 on a 4.0 scale to qualify for the scholarship.
- If awarded, the scholarship will be paid following the successful completion of the first semester with a grade point average of a minimum of 2.5 on a 4.0 scale; and the recipient's enrollment as a full time student for both the first and second semester.
- The scholarship recipient will forfeit their right to this scholarship if not used within 12 months from the date awarded.
- The recipient of the scholarship may receive the scholarship only once.
- Graduate students are not eligible for the scholarship.
- The Walworth County Farm Bureau board of directors reserves the right to determine qualifications and criteria for this award, and the selection of the recipient.
