In response to legislation passed during the 2025 Legislative Session, a task force was established to study property taxes. The Comprehensive Property Tax Task Force will be assigned to conduct a comprehensive review of property tax policies and identify impactful, substantive measures to provide significant and lasting tax relief for the homeowners of this state. The Agricultural Land Assessment Implementation and Oversight Advisory Task Force also known as the "Ag Land Assessment Task Force" received its appointments for the next two years. The task force was created in 2008 when South Dakota moved to the current productivity methodology to assess agricultural property. The goals of the task force are to advise the Department of Revenue regarding the rules promulgated to administer the
